Capacity building

Certificate Course On "Evidence Synthesis: Systematic Review and Meta-analysis"

Public Health Evidence South Asia (PHESA) has initiated a certificate course on 'Evidence synthesis: Systematic review and Meta- Analysis'. The course aims at sensitizing the participants on systematic review methodology and providing detailed step-by-step guidance on how to perform systematic reviews and meta-analysis. This is the first certificate course hosted by PHESA and will be organized for a period of three months. The program was inaugurated on 3rd March'18 at 2 pm by the chief guest, Dr. Shyamala Hande, Deputy Registrar Academics -Health Sciences MAHE, Manipal. The other dignitaries present were Dr. N. Sreekumaran Nair,

Professor and Head, Department of Biostatistics, Jawaharlal Institute of Postgraduate Medical Education and Research, Puducherry, Dr. B. Unnikrishnan, Associate Dean & Professor, Community Medicine, KMC Mangalore and Dr. Suma Nair, Professor & Head, Department of Community Medicine, KMC Manipal. Twenty-two participants representing various disciplines from Manipal and Mangalore, registered for the course.



This course is based on the principle of "Learning by doing". Objective of the course is to sensitize the participants to systematic review methodology and provide detailed and steady guidance on how to perform a systematic review and meta-analysis. Every step of a systematic review will be elaborately explained and practical exposure will be provided in the form of practice exercises, take-home assignments, group activities and hands-on training. Participants will also be provided with practical tips on do's and don'ts during the review process. At the end of this course, participants will understand the importance of SR and gain in-depth knowledge about systematic review methodology.

Pre conference Workshops-31st January and 1st February 2018

Mixed Methods for Systematic Reviews



A half day workshop on Mixed Methods for Systematic Reviews was conducted on 31st January 2018. Dr. Shrinivas Darak, Senior Researcher, PRAYAS Health Group, Pune, talked about the basics of mixed methods research, from the theories and scientific paradigm to the synthesis of primary and systematic review in his workshop.

Research to Community through Media

Professor Subhadra Menon, Executive Director (Research), Kailash Satyarthi Children's Foundation, New Delhi, talked about packaging research evidence for improved public health outcomes. Professor Menon discussed the current reach and challenges of taking research to the policymakers for change, and fr where it was generated, the community.

Determinants of neonatal pneumonia and factors associated with its mortality in India: a systematic review combined with qualitative research approach

Funded by: Bill and Melinda Gates Foundation and The Inclen trust International

India has the greatest number of neonatal deaths in the world. Through 3 systematic reviews, the study will address the dearth of consolidated evidence on the determining factors and barriers to the case management of neonatal pneumonia in the Indian context. Moreover, various Stakeholders at all levels of the neonatal healthcare system will be interviewed for better understanding of their perceptions on the prevention and management of neonatal pneumonia.





Effectiveness of behaviour change communication interventions in delivering health messages on antenatal care: an evidence summary of systematic reviews

Funded by: DFID

Maternal and child health (MCH) outcomes have remained poor in low and middle income countries. The coverage of antenatal care (ANC, at least four visits during pregnancy), one of the indicators of maternal health, is 56% in the South Asian region. One of the most cost effective ways of targeting the issues of MCH is through behaviour change communication. This evidence summary of systematic reviews aimed to identify different types and mediums; and the most effective BCC. This project is currently under dissemination phase and manuscript writing based on review findings are in progress.

A systematic review on barriers to exclusive breast feeding

Exclusive breast feeding is defined as, "no other food or drink, not even water, except breast milk (including milk expressed or from a wet nurse) for six months of life, but allows the infant to receive ORS, drops and syrups (vitamins, minerals and medicines)". Despite all the potential benefits of breast feeding only about two fifths of the infants globally are exclusively breast fed for the first six months. The study aims to identify the significant barriers which women face for EBF. By identifying the barriers to exclusive breastfeeding we will be able to develop new strategies to help mothers to exclusively breast feed their babies for the initial six months of life and achieve the global target for EBF.

Malnutrition is one of the important public health concern in the world. It not only affects health of an individual but also has an impact on the economic, development, social aspects of a country. The evidence summary, intends to summarize available evidence on the effect of food fortification and supplementation on the nutritional status of reproductive age women. Comparisons will also be done for the effect of fortification and supplementation and/or combination of both on nutritional status of women, so that the intervention that is more appropriate for the vulnerable population can be advocated.

Contextualizing the evidence from systematic review on effect of unconditional cash transfers on use of health services and health outcomes in low and middle income countries to South Asia

Unconditional cash transfer (UCTs) programs aim to reduce poverty by providing welfare programs without any conditions upon the receivers' actions. A systematic review was completed by Pega et al and published in Cochrane Public Health in November 2017. The systematic review made robust evidence available on the effect of UCTs on use of health services and health outcomes. Contextualizing the evidence from the systematic review will help

Summer school on Qualitative Research Methods for Health Sciences April 9-13, 2018



Trans-disciplinary Centre for Qualitative Research Methods (TCQM) in collaboration with Department of Community Medicine Kasturba Medical College, Mangalore and Manipal Academy for Higher Education, Manipal, organized Summer School on Qualitative Research Methods for Health Sciences. This Summer School was held at Manipal from April 9-13 and was attended by 13 participants from different universities from India and abroad.

The aim of the Summer school was to enhance the capacity of public health researchers in synthesizing

evidence, using qualitative methods. Summer school sessions included lectures and practice on qualitative research designs, qualitative methods for data collection and data analysis with Atlas.ti software. Dr. Ajay Bailey, Assistant Professor Transnational Mobilities, International Development Studies, Department of Human Geography and Spatial Planning, Utrecht University and Dr. T. M. A. Pai Endowment Chair in Qualitative Methods, Manipal Academy of Higher Education, Manipal, Dr. Shrinivas Darak and Mr. Nikhil P.N., Research Scholar, University of Groningen, led the different sessions in Summer school.

Certificate course on qualitative research methods

TCQM is organizing a Certificate Course on Qualitative Research Methods. This certificate course is designed to teach various steps involved in qualitative research methods such as research design, participant recruitment, in depth interviews, focus group discussions, observations, data management, analysis and presentation to participants. Total 12 participants have been enrolled in the program and the course structure for the program includes both class room teachings and assignments. Each



participant is working on an individual assignment with the aim to develop strong skills in qualitative research methods. This certificate course is designed and lead by Dr. Ajay Bailey.

Atlas.ti Qualitative Data Analysis Lab

As a centre aims to establish a regional hub for qualitative research, TCQM has established a Qualitative Data Analysis Lab with Atlas.ti software. This lab aims to become as a platform for young researchers to enhance their capacities in conducting qualitative research. This research lab is equipped five laptops with Atlas.ti software. Based on request, researchers can utilise the Atlas.ti lab facilities irrespective of their disciplines.
